### Please submit the following:

- Completed application
- Check payable to Holistic Treasures. \$75 booth fee, \$15 late fee, if applicable.
- This is a JURIED show. Good images are very important. 3 images of your work/art and 1 of your booth set up. Please mail photos with your name and contact info on the back, or email your images to elzcave@rcn.com. Emailed images should be numbered and include your name. Images are required of ALL applicants.
- Self addressed stamped envelope. Please provide enough postage to return your photographs.

**There are no refunds after acceptance.** Acceptance notification will be by email after the jury process. Your cashed check is your receipt. If you are accepted your photos will be kept on file unless your request their return. If you are not accepted, your check and photos will be returned. Please include a self addressed, stamped envelope.

**This is a rain or shine event. There will be no refunds for inclement weather.**

**SET UP** Set up times are staggered and pre assigned. If you need a long amount of time to set up please specify on your application. Set up begins at 8:30am. All booths must be set up and ready by 10:45am. Complimentary coffee for exhibitors will be provided during set up.

**TEAR DOWN** is from 4pm -6pm. Please, no packing up before 4pm. All exhibitors need to be packed and off the grounds by 6pm.

**Only original artwork or crafts are permitted. No imports, no resale.** The organizers will assign spaces as they see fit and reserve the right to decline any application if items are not handmade by the applicant and/or if the application is incomplete.

You may sell only what you submitted in your application. Non approved items will not be allowed for sale.

**ELECTRICITY** is available by special request only.

**Tables, chairs, and canopy.** Artisans must provide their own.

**Raffles and solicitations** are not permitted unless approved by Holistic Treasures.

**EXHIBITOR PARKING** is located at Weston Nurseries "main office" on Phipps Street. Exhibitors will unload their items in the upper parking lot behind the Garden Center, then park in the exhibitor parking lot at the TOP of the hill. Only after you have moved your car should you begin to set up your space. You may use the garden carts located at the garden center to help move your things. Please be aware that many of exhibit spaces are on GRAVEL over packed stone dust. Some spaces are on grass.

You may **not** drive your car to your space.

BY REQUEST ONLY Shuttle will be available to bring you from the parking area to exhibitor space, if necessary, otherwise it's just a short walk. Handicapped parking is available for those who require/request it.

**RESTROOMS** are located in both Garden Center buildings 8:30am – 6pm.

**Buildings will NOT open until 8:30am.**

**FOOD PERMIT FOR CONSUMABLES:** If your craft/work is intended for consumption you must obtain food permits from the Hopkinton Board of Health (Ph. #508-497-9725) and abide by their regulations. Holistic Treasures & Weston Nurseries have no control over the decision of the Board of Health regarding the granting or revoking of temporary food service permits. Must apply at least 14 days before event but it's a good idea to contact them asap..
